

Ending Operations Transition Plan

Overview

Operators that intend to end the operations of a multi-tenant house are required to submit this Ending Operations Transition Plan form to the Executive Director, Municipal Licensing and Standards for approval.

The form must be submitted at least <u>210 days in advance</u> of ending the operations of the multi-tenant house.

In addition to providing information on the multi-tenant house, operators must fill out this form to provide:

- The date on which operators intend to end the operations;
- The operator's reasons for ending the operations of the multi-tenant house;
- A description of how the operator intends to use the building after ending operations;
- The date by which the operator will give each tenant written notice of the date that operations will end;
- · A list of alternate accommodation that may be available to tenants; and
- A list of community organizations that may be affected by the end of operations.
